President Rodriguez stated he received communication from Chief Smith asking if they can move forward with the two applicants that tested in December: Yokovich and Williams.


A motion was made by Commissioner Sloss for the applicants to move forward to the next step. Second by Commissioner Peterson.

Motion Carries


